CONSUMER SURVEY OF ONLINE COPYRIGHT INFRINGEMENT

IPS was engaged to conduct the fourth wave of a longitudinal study involving consumer surveys on online copyright infringement in Australia. IPS coordinated the fourth-year data collection in line with previous years to ensure comparative analysis. The quantitative data was collected via online and CATI platforms, and analysed to produce a comprehensive report. The report will be used to inform the Australian Government's broad reform agenda to reduce online copyright infringement.
